### Admission Requirements

- Be at least 17 years old at the time of a student's program start date and be at least 18 years old by the time of the student's program completion date.
- Be a high school graduate or have earned a GED certificate. Submission of a copy of a student's high school transcript, high school diploma, or GED certificate is required to complete a student's enrollment file and must be submitted before the program start date.
- Be able to read, write, and understand English.
- Welding is a physically demanding career, and Arkansas Elite runs its training programs as a job site which means your training is physically demanding. Arkansas Elite recommends that all new students have seen their primary care physician for a physical and have had a recent eye exam. Please note that welding in contact lenses is prohibited. If you need corrective lenses, you must wear glasses. *Please note that while physical handicaps do not preclude a student from admission to the school, individuals with physical handicaps should consult with their physician and Arkansas Elite Welding Academy to determine if the training requirements can be accomplished.*

## **Enrollment Steps**

Visit [www.arkansasewa.com](http://www.arkansasewa.com). Click the red “Apply Now” button, and then choose the program you would like to enroll in. Complete the enrollment form and submit. Upon submission you will be asked to make a \$250 payment. The \$250 payment includes a \$100 non-refundable registration fee and a \$150 refundable tuition deposit that is applied toward an applicant’s final bill. The enrollment form is not complete until this \$250 payment is made. Upon receipt of the enrollment form, including payment, an Arkansas Elite Welding Academy representative will confirm your start date and reserve your booth space. *Please note that start dates are filled on a first come, first served basis. If the originally selected start date is filled by the time the enrollment form and payment is received, the applicant will be contacted to select an alternate start date.*

## **Transfer of Credits**

Arkansas Elite Welding Academy programs are determined by clock hours instead of credit hours; therefore, Arkansas Elite does not issue credits. Transferability of Arkansas Elite’s clock hours to another institution is determined exclusively by the receiving institution. No person can imply or guarantee that clock hours will be converted to credits to be transferable. As a vocational training program, it is very unlikely that any credit will be given for training received at Arkansas Elite Welding Academy by another post-secondary institution that offers credits instead of clock hours

Arkansas Elite Welding Academy does not give credit for prior welding training. All students begin at the beginning of their program curriculum and progress through the entire curriculum, regardless of prior weld knowledge possessed. ### **Arkansas Elite Welding Academy Welding Competition Scholarship Policy**

Arkansas Elite Welding Academy hosts a Welding Competition each year for current high school seniors. All Arkansas Elite Welding Academy Welding Competition participants receive a tuition discount scholarship. Top scholarships are awarded for the competition winners. Arkansas Elite Welding Academy also awards competition scholarships each year to current high school seniors at various other competitions. **A student may only use ONE (1) Arkansas Elite Welding Academy Welding Competition Scholarship.**

#### **NOTES:**

- *Arkansas Elite Welding Academy scholarships can be applied to tuition charges only and cannot be used for materials fees or tools fees. No refunds will be issued from an Arkansas Elite Welding Academy scholarship.*
- *If a student competes at the Arkansas Elite Welding Academy welding competition and receives a participation scholarship and a top scholarship, only the top scholarship will be applied to their tuition bill.*
- *If a student competes at multiple competitions and receives multiple Arkansas Elite Welding Academy scholarship awards, the student can select one scholarship award to use toward their tuition bill.*
- *Arkansas Elite Welding Academy does not award any scholarships as cash prizes.*

Arkansas Elite Welding Academy scholarships are non-transferrable and have the following expiration deadlines. A student must enroll\* within 12 months of their high school graduation date and begin\*\* an Arkansas Elite Welding Academy program within 18 months of their high school graduation date.

*\*Enroll means a student must have completed an enrollment form, paid the \$100 non-refundable application fee and the \$150 refundable tuition deposit, and reserved their spot for a future start date.*

*\*\*Begin means that a student starts attending classes in an Arkansas Elite Welding Academy program of study.*

#### **Example:**

A student competes at an April 2024 competition.

They will graduate from high school in May of 2024.

They must enroll at Arkansas Elite Welding Academy by the end of April 2025.

They must begin a program by the October 2025 start date.

## **Payment Policy**

Upon enrollment, a student will be billed for the full cost of their program. An invoice will be mailed to the student in the acceptance packet and then again with the orientation packet approximately one month prior to each student's start date. Invoices can be emailed upon request. The program cost must be paid in full, or funding source(s) confirmed, by the payment deadline for each start date. Students not able to complete the payment process will be moved to a future start date. Arkansas Elite Welding Academy accepts payments via credit/debit card, ACH, cash, or check. If making a payment by credit/debit card, a 3.4% processing fee will be assessed. This fee is not refundable. Contact Sancy Faulk at 501-755-1073 to make a payment by debit/credit card.

## **Documentation of Student Accounts**

Any funds received from, or on behalf of, a student shall be recorded on the Student Ledger in each student's file in a timely manner. The funding source and reason for charges shall be clearly identified. Receipt of payment will be provided to the student and placed in the student file.

## **Cancellation Refund Policy**

A full refund will be made to any student who cancels the enrollment contract within seventy-two (72) hours (until midnight of the third day excluding Saturdays, Sundays, or legal holidays) after the enrollment contract is executed. The date the enrollment contract is executed is the date an online application is submitted. Enrollment must be cancelled in writing by emailing [info@arkansasewa.com](mailto:info@arkansasewa.com). The school shall promptly fully refund all tuition and fees paid pursuant to the enrollment agreement. Such refund shall be made no later than thirty (30) days after cancellation. All monies paid by an applicant, less a \$25 fee, will be refunded if the applicant is not accepted by the school.

## **Withdrawal and Dismissal Refund Policy**

Students must withdraw from Arkansas Elite Welding Academy according to the withdrawal policy located on page 26 of this Student Catalog. Refunds will not be calculated or issued until the withdrawal process has been completed. Students who are dismissed by Arkansas Elite will also be subject to this refund policy.

Arkansas Elite Welding Academy uses the State of Arkansas Rules and Regulations to determine any refunds/debt after a withdrawal or termination. The effective date for withdrawal or termination, for refund purposes, will be the last date of attendance.

1. Arkansas Elite Welding Academy may retain a registration fee associated with withdrawal or termination not to exceed \$100.
2. All tuition (not including tool fees) paid in excess of the registration fee of not more than one hundred dollars (\$100) shall be refundable.

3. The refund shall be based on the cost and length of the program. All tuition beyond the current enrollment period shall be refunded when a student terminates.
  - i. At completion of less than twenty five percent (25%) of the program, the refund of tuition and lab fees shall be made on a pro rata basis
  - ii. At completion of 25% but less than 50% of the program, the student will be refunded 50% of tuition and lab fees.
  - iii. At completion of 50% but less than 75% of the program, the student shall be refunded 25% of tuition and lab fees.
  - iv. At completion of 75% or more of the program no refund is due to the student.

**Policy for Processing Student Refunds**

Arkansas Elite Welding Academy will process student refunds in accordance with federal and state regulations. Refunds will be processed within 30 Days using the Student Refund Calculation Worksheet. The Finance Director will issue a check in cases where monies are due to the student. The Student Ledger will be updated appropriately. Credit card processing fees are not refundable.

If a student received funding from the Arkansas Rural Endowment Fund, refunds generated in cases of withdrawal or dismissal will be returned to the Arkansas Rural Endowment Fund.

**Notification of Funding Agency Upon Student Cancellation, Withdrawal, or Dismissal**

Arkansas Elite Welding Academy will notify a student's funding agency upon their cancellation, withdrawal, or dismissal.



## **POLICIES FOR STUDENTS RECEIVING VA EDUCATION BENEFITS**

### **VA Pending Payment Policy**

In accordance with Title 38 US Code 3679(c), this educational institution adopts the following additional provisions for any students using U.S. Department of Veterans Affairs (VA) Post-9/11 GI Bill® (Ch.33) or Vocational Rehabilitation & Employment (Ch.31) benefits, while payment to the institution is pending from VA.

*GI Bill® is a registered trademark of the U.S. Department of Veterans Affairs (VA).*

This educational institution will not:

- Prevent the student's enrollment;
- Assess a late penalty fee to the student;
- Require the student to secure alternative or additional funding;
- Deny the student access to any resources (access to classes, libraries, or other institutional facilities) available to other students who have satisfied their tuition and fee bills to the institution.

However, to qualify for this provision, such students may be required to:

- Produce the VA Certification of Eligibility (COE) by the first day of class;
- Provide a written request to be certified;
- Provide additional information needed to properly certify the enrollment as described in other institutional policies

### **Standards of Progress for VA Students**

Evaluation of progress of VA students will be conducted by the school's evaluation policy schedule. Students with a minimum of an 80% score on weld skill evaluations and safety, 85% production average, and 90% attendance average will be considered making satisfactory progress until the next scheduled evaluation.

In order for a student to be considered making satisfactory progress the student must meet all minimum requirements listed above. Students receiving VA benefits who fail to meet minimum progress and attendance requirements will be placed on **probation** for 30 days. At the end of the probationary period, the student's progress (academic and attendance) will be re-evaluated. If the student is meeting minimum requirements, the student will be determined to be making satisfactory progress and will be considered off Probation.

### **Suspension/Withdrawn/ Termination**

If the student fails to meet minimum requirements in either academics, safety, or attendance, the school's certifying official will submit a 22-1999b effective on the last day of probation.

**Reinstatement of VA student's educational benefits:** Once VA student's educational benefits have been suspended and after 30 days and the student is meeting the minimum standards of progress, the school's certifying official will submit a 22-1999.

**Refund Policy**

In the event a veteran fails to enter the course or withdraws or is discontinued a refund will be based on a pro rata refund of the unused portion of tuition, fees and charges. This refund will be returned promptly as required under 38 CFR 21.4255

**Prior Credit**

It is the policy of this institution that an evaluation of previous education and training will be conducted, appropriate credit granted, if applicable, the institution's duration in the course will be shortened proportionately, and that the Veteran's Administration and the student will be so notified. VA credit will be given for prior training for veterans and eligible programs.

Enrolled students will be assessed for prior credit on the second day of their program of study. Should a student wish to be evaluated for prior credit before enrollment or prior to the start of their program of study, the student will be responsible for the cost of administering appropriate weld tests.

### **Elite Structural Welding Program**

The Elite Structural Welding Program prepares students for journeyman level positions in residential, commercial, and industrial structural steel welding. These types of welders can be found in various areas such as light and heavy commercial or industrial shop fabrication, plants, refineries, power plants, manufacturing facilities, and more.

Class times for the Elite Structural Welding Program: The program will be held Monday - Thursday 7:00AM – 5:00PM. The program meets approximately 10.5 weeks at 40 hours a week of instruction. (Note: number of hours per week may vary depending on holiday schedule).

Total Program Cost: \$10,600 (*Non-Refundable Registration Fee \$100 / Non-Refundable Tools Fee \$600 / Lab Fee \$1,250 / Tuition \$8,650*)

### **Elite Pipe Welding Program**

The Elite Pipe Welding Program prepares students for journeyman level positions in commercial and industrial pipe welding. These types of welders can be found in various areas such as industrial pre-fabrication shops, paper mills, refineries, power plants, chemical plants, food processing plants, oil and gas pipelines and more.

Class times for the Elite Pipe Welding Program: The program will be held Monday - Thursday 7:00AM – 5:00PM. The program meets approximately 18 weeks at 40 hours a week of instruction. (Note: number of hours per week may vary depending on holiday schedule).

Total Program Cost: \$18,100 (*Non-Refundable Registration Fee \$100 / Non-Refundable Tools Fee \$1,000 / Lab Fee \$2,000 / Tuition \$15,000*)

### **Elite Combined Structural / Pipe Program**

The Elite Combined Structural / Pipe Program prepares students for journeyman level positions in residential, commercial, and industrial structural steel and pipe welding. These types of welders can be found in various areas such as light and heavy commercial or industrial shop fabrication, paper mills, refineries, power plants, chemical plants, food processing plants, oil and gas pipelines, manufacturing facilities, and more. This program integrates the Elite Structural Welding Program curriculum with the Elite Pipe Welding Program curriculum providing the training offered in both programs.

The way the program is designed, the Structural course curriculum will be completed first and then students will move on to the Pipe curriculum. Students who successfully complete the Structural course curriculum portion but fail to complete the Pipe course curriculum portion will still be considered a program graduate from the Elite Structural Welding Program. Brush up

benefits would be available only for Structural course curriculum. No refund will be given except as outlined in the refund policy.

Class times for the Elite Combined Structural Pipe Program: The program will be held Monday - Thursday 7:00AM – 5:00PM. The program meets approximately 23 weeks at 40 hours a week of instruction. (Note: number of hours per week may vary depending on holiday schedule)

Total Program Cost: \$24,100 (*Non-Refundable Registration Fee \$100 / Non-Refundable Tools Fee \$1,100 / Lab Fee \$2,600 / Tuition \$20,300*)

### **Elite Downhill Pipeline Program**

This Elite Downhill Pipeline Program is only available for Arkansas Elite Welding Academy graduates that have been in the field for at least one year. The Downhill program is only offered when pipeline work is available. Typically, when oil and gas prices are low, Arkansas Elite does not offer this course. For more information or to join the program waiting list, contact T. Bird.

Class times for the Downhill Pipeline Program: When offered, the program will be held Monday - Thursday 7:00AM – 5:00PM. The program meets approximately 6 weeks at 40 hours a week of instruction. (Note: number of hours per week may vary depending on holiday schedule).

Total Program Cost: \$7,600 (*Non-Refundable Registration Fee \$100 / Lab Fee \$2,500 / Tuition \$5,000*)

## **CERTIFICATIONS AND BONUS CURRICULUM**

### **CERTIFICATIONS**

Welding certifications are generated by a Certified Welding Inspector (CWI) after successful completion of a CWI administered weld test. A certification is the formal documentation given to verify successful completion of a welding process. Arkansas Elite Welding Academy, LLC has developed a weld procedure specification (WPS) for each offered program. ASME IX and/or AWS D1.1 certifications can be earned if a student passes the final test at the end of their curriculum on the first attempt. Tests are administered by an on staff CWI. Certifications are not guaranteed. Earning a certification is not a requirement for successfully completing a program, does not guarantee employment, and does not make a person more employable.

A welding certification can be earned by all students on their final test. Students can use their remaining program hours to practice for the test. Once the student has reviewed and accepted the WPS and weld test rules, they begin the test. By code requirements, a certification can only be awarded on the first test attempt. If the student fails on the first test attempt the CWI administering the weld test can offer a retest in the following two ways. One, he/she may offer an immediate two for one weld test where a student must pass two additional tests. Two, if there is enough time remaining in a student's program curriculum for the student to get additional practice, the welder will be eligible to retest. Again, a retest is at the discretion of the CWI administering the test and is not guaranteed. Students must pass the final test to successfully complete their program of study, but do not have to receive a certification to successfully complete the program.

More detailed information is available on the Weld Test Instructions which are available from a CWI.

**Certification tests are given at Arkansas Elite Test Facility.**

### **TOP GUN\***

Students enrolled in the Structural Program have the opportunity to move on to the Top Gun Bonus Curriculum if they have a minimum of 100 hours remaining after completion of the Structural Program Curriculum. The Top Gun Curriculum is offered so that students can gain practice and proficiency with more advanced types of industry welding processes. Students who complete the Top Gun Bonus Curriculum will receive a plaque and a gold seal on their program certificate of completion.

### **GOLDEN ARM\***

Students enrolled in the Pipe Program have the opportunity to move on to the Golden Arm Bonus Curriculum if they have a minimum of 100 hours remaining after completion of the Pipe Program Curriculum. The Golden Arm Curriculum is offered so that students can gain practice

and proficiency with more advanced types of industry welding processes. Students who complete the Golden Arm Bonus Curriculum will receive a plaque and a gold seal on their program certificate of completion.

\*Students enrolled in the Elite Combined Structural / Pipe Program can choose to complete one or both bonus curriculums if they have the remaining time after completing the Elite Combined Structural / Pipe Program Curriculum. Gold seals for the bonus curriculum completed will be placed on the program certificate of completion.

## PROGRAM COMPLETION STANDARDS

### Standards for Satisfactory Completion of Training

To satisfactorily complete an Arkansas Elite Welding Academy program, students must meet the following requirements:

- maintain 90% attendance average
- maintain 85% average production
- score 80% or better on all weld skill evaluations
- maintain 80% in safety
- Complete OSHA-10 training
- Complete 20 hours of job placement assistance training unless a job placement waiver is requested.
- Complete a minimum of 90% of total program hours

*Student Progress Binders are maintained and available for student review at any time. Students who fall below these standards at any time may be placed on an improvement plan. More details about student improvement plans can be found on page 28.*

Upon completion of these training requirements students will be given a Certificate of Completion and a copy of their transcript.

## **ATTENDANCE / WITHDRAWAL / DISMISSAL**

### **Attendance**

Attendance is essential to benefit from class and shop instruction. Students are required to be (1) on time for each class, (2) stay for the duration of the class session, and (3) participate fully in each shop and classroom session.

### Legal Holidays

The school will observe the following legal holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the Friday after Thanksgiving, Christmas Day. Refer to the School Calendar in Appendix A for a full listing of school closings for holidays.

### Attendance Policies

- Students must complete 90% of the required training hours and complete all curriculum requirements to receive a Certificate of Completion.
- Safety Meetings begin promptly at 7:00AM and 1:00PM each day. If students are not present at 7:00AM and 1:00PM they are considered tardy. Students who are tardy will be charged a half day absence.
- Each student will record time-in and time-out by clocking in and out with their student ID number.
- Lunch is from 12:00PM to 1:00PM.
- Students found loitering in other areas may be counted absent for the time spent away from their assigned area (booths/classroom). Absences will be charged in half day increments.
- Students are to leave and return from breaks on time daily.
- Excessive tardies, early outs, and/or absences may result in the loss of the privilege of attending make-up class times and/or dismissal from the program.
- Attendance is monitored continuously. An audit will be conducted at each program mid-point. If a student falls below the 90% average attendance requirement at any time, they may be dismissed.
- If a student's absences at any time near or exceed 10%, they will be placed on a student improvement plan. The student improvement plan will include stipulations for improving attendance.
- Students should notify the Student Advisor if they are unable to report at the scheduled time.
- Students who have not called in or attended class for 4 consecutive days will be considered dismissed. The withdrawal date will be the last date of class attended.

*NOTE: Arkansas Elite Welding Academy, LLC reserves the right to deviate from the stated attendance policy in cases where student absences are so excessive at any evaluation point that the student cannot mathematically achieve 90% attendance.*



### Friday Attendance

- Free Fridays are optional unless a student is on an improvement plan, then they are mandatory.
- Friday hours are 6:00AM to 11:00AM.
- Students do not clock in or out on Fridays.
- Students can sign up and request to attend by noon on Thursday of the week they wish to attend.
- If a student is late or misses a Friday they signed up for, Friday privileges will be suspended until further notice. This loss of privilege will be communicated to the student.
- *Students may not attend on their first Friday in the program.*

### **Clocking In and Out**

Students are given their Arkansas Elite student ID number during their orientation day. Beginning on Day 1 of his/her individual program, each student should scan in before 7:00AM each day and should scan out at the end of each day between 4:50PM and 5:00PM. Do not scan in and out for lunch and do not scan in or out on Fridays.

If a student forgets to clock in or out, he/she should inform the Student Advisor immediately. Missed clock ins or clock outs could be counted as absences/tardies.

Students should NOT clock in or out for any other student. Students should NOT ask another student to clock in or out for them. If students are caught doing this, both students will receive a write-up and face disciplinary action.

### **Leave of Absence Policy**

Leave of Absence (LOA) request must be submitted and approved by the CMT (Core Management Team). Documentation may be required. Students will be given a leave of absence form for their signature.

- If the leave of absence is no more than 2 weeks (80 hours of class), the student will resume where he/she left off in the curriculum, with a change in his/her completion date.
- If the leave of absence is longer than 2 weeks, the student will need to meet with the Student Advisor before returning to class. A weld skill evaluation may be conducted to determine the restart status after the leave of absence. Arkansas Elite must be informed 14 days prior to the proposed return to school date so that appropriate placement can be determined.
- A student in the military may leave and return with verification of the military training.
- Should a student decide not to return from the LOA, it is necessary to inform Arkansas Elite promptly and complete a withdrawal form. If the student does not communicate with Arkansas Elite, the dismissal policy may apply. The Refund Policy will be followed when calculating funds owed to Arkansas Elite or to be refunded to the student. The withdrawal date will be the last date of class attended.

When a student returns from a LOA, the student will return to school in the same progress status as prior to the LOA. Hours elapsed during a LOA will extend the student's contract period

and . maximum time frame by the same number of days taken in the LOA and will not be included in the student's cumulative attendance percentage calculation.

### **Withdrawal Policy**

Students wishing to withdraw from their program should contact the Student Advisor to complete a withdrawal form. The withdrawal date will be the last class date the student attended, regardless of when the form is completed. If a student does not attend class and does not complete a withdrawal form for four consecutive days, the Dismissal Policy will apply.

The Refund Policy will be followed when calculating funds owed to Arkansas Elite or to be refunded to the student and/or funding agency.

The re-admittance procedure is applicable should a withdrawn student desire to return to class.

### **Dismissal Policy**

A student may be dismissed by Arkansas Elite if his/her attendance falls below the 90% average requirement, daily production falls below the 85% average, and/or a student's cumulative score on weld skill evaluations falls below 80%, and/or a student's safety score falls below 80%. A student can also be dismissed because of a conduct issue. If a student is dismissed for one of these reasons, a dismissal form will be completed. A Core Management Team (CMT) member and the Student Advisor will meet with the student to explain the dismissal. The student and an Arkansas Elite representative will sign the dismissal form. If the student is not available for a meeting, the student will be notified of the dismissal by phone.

A student will be considered dismissed when they have not contacted Arkansas Elite or attended class for four (4) consecutive days. Students will be notified of this action. The date of dismissal will be the last class date the student attended. The date of determination would be the date that Arkansas Elite determines that a student has been absent without notice for four (4) consecutive days.

The Refund Policy will be followed when calculating funds owed to Arkansas Elite or to be refunded to the student and/or funding agency.

The re-admittance procedure is applicable should a dismissed student desire to return to class.

### **Re-Admittance after Withdrawal or Dismissal**

The student who desires re-admittance after withdrawal or dismissal must first make an appointment with the Student Advisor. The Student Advisor, along with a member of the CMT, will determine if the student has resolved the problems causing the dismissal or withdrawal. Any outstanding debt to the school shall be met before re-admittance can occur. The returning student's weld skills will be re-evaluated to determine placement. The Student Advisor will determine an appropriate start date by reviewing daily production sheets and results of weld evaluations. The student will begin at the next available start date. Students who withdraw

prior to completion of the course and wish to re-enroll will return in the same academic progress status as at the time of withdrawal or dismissal.

## **PRODUCTION and WELD SKILL EVALUATION**

### **Production**

Arkansas Elite Welding Academy has set production for each task in curriculum. Students are assigned a daily production score by an instructor based on what was accomplished that day. A production score is given for each day a student is in attendance. All production scores are averaged and must remain above an 85% for successful program completion. Students who fall below an 85% average will be placed on an improvement plan (see more information below).

Production sheets are colored coded by program. Students are to get a new production sheet each morning BEFORE the 7:00am roll call. If a student fails to do this, his/her production score could be affected. If a student fails to get a production sheet or loses his/her production sheet during the day, that student should see the Student Advisor.

### **Weld Skill Evaluation**

When a student completes a weld skill in the curriculum, an instructor will grade that weld. These grades are reflected on students' final transcripts. Students must maintain a minimum average of 80% on all weld skill evaluations for successful program completion.

### **Student Performance Monitoring**

An audit will be conducted at each program mid-point by and the Student Advisor and the Lead Instructor. If safety, production, or weld skill evaluations fall below the minimum satisfactory requirements listed on page 22, the student will be placed on an improvement plan and monitored. Student progress is monitored daily in accordance with the curriculum pacing guide. Students are notified of their placement on an improvement plan if they are not making satisfactory progress. If a student falls below any of the standards at any time, they may be dismissed.

*NOTE: Arkansas Elite Welding Academy, LLC reserves the right to deviate from the stated Student Performance Monitoring policy in cases where student performance is so low at any evaluation point that the student cannot mathematically achieve the minimum satisfactory requirements.*

### **Student Improvement Plan**

Students who fail to maintain standards may be placed on an improvement plan in order to bring their attendance, safety, production, and/or weld skill evaluations up to minimum standards. A Student Improvement Plan is considered a probationary period to allow a student the opportunity to meet minimum standards. Students who do not follow their student improvement plan, or who do not make progress in the curriculum, may be dismissed from the program.

## **SAFETY**

A safety session, along with a Safety Orientation Test, is part of Orientation Day activities.

### **OSHA-10 Training**

Students are also required to complete OSHA-10 training as part of their program curriculum. Students will log in and create an account during orientation. Students must complete the OSHA-10 training before class begins on the Monday following his/her program start date. If these deadlines are not met, students will be suspended, and unable to attend classes, until the training has been completed. All hours missed while on suspension are counted as absences. In addition, not completing OSHA-10 training by the deadline will result in a safety violation and will be documented with a student incident form and placed in the student's permanent file.

*NOTE: If students need access to a computer, they can use a computer in the student lab daily before class begins and on Fridays.*

### **Safety Score**

All students begin an Arkansas Elite program with a 100% in Safety. Each safety violation will result in a 10% grade deduction, documented with a student incident form that will go in the student's permanent file. On the second violation, a student may be suspended or dismissed at the discrepancy of the Lead Instructor and Safety Coordinator. If a suspension occurs, a student in the Structural Course will be suspended for 2 days, a student in the Pipe course will be suspended for 3 days, and a student in the Combined course will be suspended for 4 days. The second violation and consequence will be documented on a student incident form and placed in the student's permanent file. All hours missed while on suspension are counted as absences. Upon receiving a third safety violation a student will be dismissed from the program.

### **Dress Code**

Students will be expected to dress appropriately for a welding vocation. Students must always wear cotton or FR long sleeved shirts, long pants, and safety toe leather work boots. Safety glasses shall always be worn in the shop area. The items listed above are mandatory. If proper dress code is not followed, students will be sent home to obtain the proper attire. While students are obtaining the proper attire, the attendance policy will apply.

### **Safety Protection Guidelines**

- All students must wear jeans or work pants and a long-sleeved cotton shirt. FR clothing is not required, but is acceptable, and may be required on job sites.
- Safety toe leather work boots are required. The boots should be in good condition, free of holes and frays.
- ANSI Z87+ approved safety glasses are always required in the shop when across the yellow safety line.
- Welding in contact lenses is prohibited. If students need corrective lenses, glasses must be worn. ANSI Z87+ prescription safety glasses are preferred. Side shields for regular prescription glasses are located in the Arkansas Elite Tool Room.
- Students shall wear safety glasses underneath their welding hood while welding
- Students shall wear safety glasses, clear face shield and leather gloves while grinding or using rotating equipment (porta-band saw, bench grinder etc.)
- Students shall have, at a minimum, the front of their shirttail tucked in while using rotating equipment such as grinders or bandsaws
- Students shall wear safety glasses along with a properly tinted (shade 5 minimum) face shield while flame cutting.
- Students shall wear leather gloves while handling material and performing any type of hot work such as (welding or flame cutting processes).
- Pants shall be outside, and not tucked, into boots
- When hearing protection is required, ear plugs are located on the wall next to the stairwell in the shop. They are also available in the prep shack on the left as you walk in.

*NOTE: Environmental conditions may necessitate requiring additional safety equipment or guidelines, either temporarily or permanently. Students will be notified of such changes and expected to comply.*

### **Inclement Weather Policy**

Arkansas Elite Welding Academy, LLC will be closed whenever Quitman Public Schools are closed due to inclement weather. A notification will be posted in Google Classroom and on Arkansas Elite social media.

In instances where Arkansas Elite does not close, it is each students' responsibility to determine if safe travel is possible from outlying areas. If it is not possible, the student should contact the Student Advisor to inform Arkansas Elite of the absence.

## **STUDENT SERVICES**

### **Computer Lab**

Arkansas Elite Welding Academy provides an on-site computer lab used during the job placement assistance portion of the curriculum. Students are able to use the computer lab for resume development, craft profile development, job searches, and job application.

### **Job Placement Assistance**

Job attainment for all programs will be based on the individual's ability to pass the contractors weld test(s) based on the governing code of construction, testing, and the weld test administrator. Arkansas Elite Welding Academy does not guarantee employment or wages upon program completion.

Students complete twenty (20) hours of Job Placement Assistance Training as part of each program's curriculum. Students are provided with resume assistance, assistance in creating and completing online profiles with contractors, and assistance making calls about potential jobs. Students will demonstrate the ability to apply for jobs, speak to recruiters and HR Personnel, schedule weld tests and begin employment.

Arkansas Elite Welding Academy in no way guarantees employment or wages upon program completion.

### **Job Placement Assistance Waiver**

Job Placement Assistance Waivers are available for students who have a job lined up prior to beginning the Job Placement Assistance Program or who do not plan on obtaining employment within 30 days of a completion date.

### **Tool Room**

Arkansas Elite Welding Academy provides an on-site Tool Room managed by the Logistics and Materials Manager. The Tool Rom is stocked with tools and supplies needed for the welding profession. Students are able to purchase items during regular business hours.

## **ALUMNI SERVICES**

Students who successfully complete a program are eligible for alumni benefits. The benefits and how to retain them are listed.

Part of a student's graduation checklist is signing a Graduation and Job Placement Assistance Agreement. Those terms are outlined below:

### **Graduation/Job Placement Agreement**

Arkansas Elite Welding Academy, LLC. will help each graduate secure initial employment by training them to contact potential contractors via phone, e-mail and online resume submission. Arkansas Elite will provide and demonstrate the efforts necessary to secure employment in the welding field. Arkansas Elite does not discriminate or place individuals on jobs based on sex, race, ethnicity, etc. However, individuals may be directed towards employment for which they would be most suited to be successful based on competence or skill levels demonstrated during training. Lifetime job placement assistance is a privilege and may be revoked (see criteria below). Arkansas Elite reserves the right to contact past graduates for employment options based on multiple stipulations such as competence, skill level, employer feedback etc.

**Below are the Arkansas Elite Welding Academy employment guidelines that must be followed. If these guidelines are not followed the individual waives all rights to Job Placement Assistance and any recommendation for future employment.**

- 1) Graduate may not fail, avoid or falsify any pre-employment or post-employment drug screenings.
- 2) Graduate must send a copy of 1 full week check stub in a welding related field within 30 days of graduation. Must send to [jodom@arkansasewa.com](mailto:jodom@arkansasewa.com) or 501-654-4842. If check stub is not received within 30 days of graduation, graduate will be removed from the alumni Facebook page.
- 3) Graduate agrees to provide job foreman's name and number for on-the-job performance monitoring.
- 4) Graduate must receive a good report upon completion of job to be eligible for future recommendations.
- 5) Graduate may not lose employment for any reason involving insubordination, sexual harassment, discrimination, horseplay or unsafe acts, excessive tardiness or absences, etc.

**Below are the Arkansas Elite Welding Academy Graduate Benefits that may be lost in the case that this agreement is not met.**

- 1) Lifetime brush up and practice eligibility.
- 2) Resume and other Graduate Assistance Services.
- 3) Arkansas Elite Alumni Facebook page availability.
- 4) Eligibility to enroll in other Arkansas Elite Welding Academy welding courses
- 5) Eligibility to be recommended for future jobs or any employment with potential contractors.



## **Alumni Benefits**

### Job Placement Assistance

Graduates are added to the “AR E. W. A. Alumni” Facebook page where jobs are shared by employees and program alumni.

Contractors frequently call requesting welders for jobs. Alumni are matched to these requests based on skill and experience and are provided the information to call and set up weld tests.

**Arkansas Elite Welding Academy in no way guarantees employment or wages upon program completion.**

### Lifetime Brush Up and Practice

Graduates wishing to utilize their “lifetime brush up and practice” benefit should contact Josh Waymack to schedule an appointment time. Appointments are available Mondays through Thursdays, during regular business hours, on a space available basis. Graduates with a scheduled weld test will be given priority. Graduates may only schedule for four consecutive days. Safety guidelines and conduct policies apply to graduates. Failure to adhere to these guidelines and policies could result in loss of graduate benefits. Brush up assistance applies to previously taken weld skills only. Graduates are required to supply their own welding and safety gear. Brush up expectations are as follows:

#### **Brush-Up Expectations**

Arkansas Elite Alumni are expected to lead by example using their knowledge and experience gained from the field to show proper work standards and PPE use.

- Text Josh Waymack (501-743-0141) prior to brushing up. Please do this during school hours M-F 7:00-5:00.
- You must be here at 7:00am and attend safety meeting.
- You can not use a booth that is already occupied by a current student.
- Check out a table from the tool room and return the table CLEAN at the end of the day.
- You are required to get a booth signature at the end of the day. Make sure Lucas verifies your booth has been properly cleaned.
- Must be productive. If you are causing a disturbance to other students or Instructors or “Just hanging out”, you will be asked to leave.
- Must follow all Arkansas Elite safety guidelines and conduct policies.
- Place colored production sheet on counter at Jake’s window when you leave.
- Brush-up benefits apply only to the course you successfully completed and received a graduation certificate.

If an alumnus does not adhere to these expectations, he/she will be denied future Brush-Up privileges.

### Resume Assistance

Graduates needing resume assistance should contact Josh Waymack to schedule an appointment time. The on-site computer lab is also available for graduates wishing to conduct a job search, create craft profiles, or apply for jobs.

### **Alumni Benefits for Non-Graduates**

Non-Graduates who meet the following criteria can petition to become eligible for alumni benefits. Verification of all criteria should be submitted to Jake Odom, Student Advisor, at [jodom@arkansasewa.com](mailto:jodom@arkansasewa.com). At that time, the information will be verified and sent to the Arkansas Elite Welding Academy Core Management Team for review. A response will be sent to the student within two weeks of receipt of petition and all supporting documentation.

Criteria to be met:

- Student was in good standing on their last day of attendance
- Student was meeting attendance, production, and safety standards on their last day of attendance
- Student completed at least 90% of program hours but did not complete curriculum **OR** student completed curriculum but did not complete 90% of program hours
- Student sent a full week's check stub within 30 days of the last day of attendance
- Student has a minimum of 6 months of work history
- Contractor / employer feedback may be considered

***NOTE: Meeting the criteria listed above does not guarantee benefits will be given. Many factors, including work ethic and attitude, both while a student and in the field, will be considered.***

## **STUDENT RECORDS**

### **Access to Student Records**

Instructors and/or students are permitted view binders, including curriculum and production sheets, at any time upon request. Instructors and/or students should contact the Student Advisor to request access. Instructors and/or students can view binders with the Student Advisor. If the Student Advisor is not present, students can request access from an Instructor.

A Student's file, which include enrollment information and payment information, can be viewed by the student at any time by request to the Enrollment Director or Finance Director.

Upon program completion, the binder and student file will be combined into the student file.

Alumni may request their records from the Student Advisor, Enrollment Director, or Finance Director.

Student Records will be locked and stored in fireproof cabinets while unattended.

### **Maintenance and Retention of Student Records**

Arkansas Elite Welding Academy shall record all student transcript records indefinitely. These will be kept in hard copy and electronic form. Enrollment information, payment information, production sheets, etc. will be maintained for at least three (3) years following completion, dismissal, or withdrawal of the student. These will be kept in hardcopy. ALL hard copies of student records will be maintained in a Fireproof Cabinet for the first three (3) years, unless electronic back up has been scanned to external hard drive or uploaded to student tracking system.

Student Records shall be open for inspection by authorized representatives of the Arkansas Division of Higher Education or the Department of Veterans Affairs.

The school may retain a student's academic transcript, certificate of completion, or any pertinent record if a student's financial obligations are not paid in full.

### **Transcript Request**

Students in good standing can request a copy of their transcript from the Finance Director.

### **The Family Educational Rights and Privacy Act (FERPA)**

The Family Educational Rights and Privacy Act (FERPA) affords eligible students certain rights with respect to their education records. An "eligible student" under FERPA is a student who is 18 years of age or older or who attends a postsecondary institution at any age.

These rights afforded to eligible students with respect to education records include:

1. The right to inspect and review the student's education records within 45 days after the day the School receives a request for access. A student should submit to the Finance

Director a written request that identifies the record(s) the student wishes to inspect. The school official will make arrangements for access and notify the student of the time and place where the records may be inspected. If the records are not maintained by the school official to whom the request was submitted, that official shall advise the student of the correct official to whom the request should be addressed.

2. The right to request the amendment of the student's education records that the student believes is inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

A student who wishes to ask the school to amend a record should write the school official responsible for the record, clearly identify the part of the record the student wants changed, and specify why it should be changed.

If the School decides not to amend the record as requested, the School will notify the student in writing of the decision and the student's right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the student when notified of the right to a hearing.

3. The right to provide written consent before the School discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent.

The School discloses education records without a student's prior written consent under the FERPA exception for disclosure to school officials with legitimate educational interests. A school official is typically includes a person employed by the School in an administrative, supervisory, academic, research, or support staff position. A school official also may include a volunteer or contractor outside of the School who performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, or collection agent or a student volunteering to assist another school official in performing his or her tasks. A school official typically has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibilities for the School.

4. The right to file a complaint with the U.S. Department of Education concerning alleged failures by the School to comply with the requirements of FERPA. The name and address of the office that administers FERPA is:

### **Directory Information Public Notice**

Schools may disclose, without consent, "directory" information. Arkansas Elite considers the following to be directory information: a student's name, address, telephone number, date and place of birth, photograph, program enrolled in, program completion date, and dates of attendance.

Schools must notify eligible students annually of their rights under FERPA, and Arkansas Elite makes this disclosure through the Student Catalog.

See the list below of the disclosures that postsecondary institutions may make without consent. FERPA permits the disclosure of PII from students' education records, without consent of the student, if the disclosure meets certain conditions found in § 99.31 of the FERPA regulations. Except for disclosures to school officials, disclosures related to some judicial orders or lawfully issued subpoenas, disclosures of directory information, and disclosures to the student, § 99.32 of FERPA regulations requires the institution to record the disclosure. Eligible students have a right to inspect and review the record of disclosures. A postsecondary institution may disclose PII from the education records without obtaining prior written consent of the student:

- To other school officials determined to have legitimate educational interests (see #3 in the listing above)
- To officials of another school where the student seeks or intends to enroll, or where the student is already enrolled if the disclosure is for purposes related to the student's enrollment or transfer, subject to the requirements of § 99.34. (§ 99.31(a)(2))
- To authorized representatives of the U. S. Comptroller General, the U.S. Attorney General, the U.S. Secretary of Education, or State and local educational authorities, such as a State postsecondary authority that is responsible for supervising the School's education programs. Disclosures under this provision may be made, subject to the requirements of §99.35, in connection with an audit or evaluation of Federal- or State-supported education programs, or for the enforcement of or compliance with Federal legal requirements that relate to those programs. These entities may make further disclosures of PII to outside entities that are designated by them as their authorized representatives to conduct any audit, evaluation, or enforcement or compliance activity on their behalf. (§§ 99.31(a)(3) and 99.35)
- In connection with financial aid for which the student has applied or which the student has received, if the information is necessary to determine eligibility for the aid, determine the amount of the aid, determine the conditions of the aid, or enforce the terms and conditions of the aid. (§ 99.31(a)(4))

- To organizations conducting studies for, or on behalf of, the school, in order to: (a) develop, validate, or administer predictive tests; (b) administer student aid programs; or (c) improve instruction. (§ 99.31(a)(6))
- To accrediting organizations to carry out their accrediting functions. (§ 99.31(a)(7))
- To parents of an eligible student if the student is a dependent for IRS tax purposes. (§ 99.31(a)(8))
- To comply with a judicial order or lawfully issued subpoena. (§ 99.31(a)(9))
- To appropriate officials in connection with a health or safety emergency, subject to § 99.36. (§ 99.31(a)(10))
- Information the school has designated as "directory information" under § 99.37. (§ 99.31(a)(11))
- To a victim of an alleged perpetrator of a crime of violence or a non-forcible sex offense, subject to the requirements of § 99.39. The disclosure may only include the final results of the disciplinary proceeding with respect to that alleged crime or offense, regardless of the finding. (§ 99.31(a)(13))
- To the general public, the final results of a disciplinary proceeding, subject to the requirements of § 99.39, if the school determines the student is an alleged perpetrator of a crime of violence or nonforcible sex offense and the student has committed a violation of the school's rules or policies with respect to the allegation made against him or her. (§ 99.31(a)(14))
- To parents of a student regarding the student's violation of any Federal, State, or local law, or of any rule or policy of the school, governing the use or possession of alcohol or a controlled substance if the school determines the student committed a disciplinary violation and the student is under the age of 21. (§99.31(a)(15))

Upon entry to the School, students will have the opportunity to complete a "Consent to Release Education Record" form. This form allows students to give authorization to individuals they wish to have access to their education records. This declaration will remain in effect until revoked in writing by the student. Please note that parents may obtain non-directory information (including information related to grades and attendance) at the discretion of the institution and only after it has been determined that their student is legally their dependent.

## **STUDENT GRIEVANCE PROCEDURE AND COMPLAINTS**

The purpose of the student grievance procedure is to ensure that students have the opportunity to present grievances to a school representative regarding actions or inactions by a member of the school, including employees and students. A student may submit a grievance when he/she believes that a member of the school has violated their rights. The definition of a grievance is the violation of written policies or procedures and/or unequal application of written policies or procedures.

### **Student Grievance Policy**

Any student, who has a grievance of any kind against Arkansas Elite Welding Academy, LLC may seek resolution in writing from a member of the Core Management Team (CMT) other than the President. A list of CMT members can be found on page 5 of this publication. The grievance must be addressed by the CMT member in writing within 48 hours of the time received.

### **Appeal Procedure**

Within 48 hours of the receipt of the CMT member's decision, a student who is not satisfied with the decision may appeal one time to the Arkansas Elite Welding Academy President by submitting the following in writing:

- the original written grievance
- the director's written decision
- the reason why the director's decision is not satisfactory

The President will respond in writing within 48 hours to the student, and his decision is considered final.

#### NOTICE TO STUDENTS

This school is licensed and regulated by the Arkansas Department of Higher Education (ADHE) under Arkansas Code Annotated §6-51-601 et.seq. The school, among other things, shall:

## **STANDARDS OF CONDUCT**

By completing an Enrollment Form, students acknowledge that the student catalog and handbook is accessible to them, and they agree to abide by the school's policies and procedures as stated. Failure to comply with the directives of an Arkansas Elite Welding Academy Representative is considered insubordination.

Students have a responsibility to themselves, the school, and their peers to adhere to standards of conduct. The purpose of these rules is not to restrict the students right, but rather to ensure everyone understands what conduct is expected and necessary. Students are expected behave appropriately.

Any behavior on or off campus that is disruptive to the educational environment or that is destructive to property is unacceptable and the student may be dismissed.

The standards of conduct will be enforced according to the guidelines contained in the "Steps in Disciplinary Action" section.

Failure to comply with Arkansas Elite Welding Academy rules and policies may result in dismissal.

### **Cleanliness**

Students are expected to clean up after themselves in their booths, the shop, grinding and cutting areas, and in the break room. Failure to do so will result in disciplinary action.

### **Communicable Diseases**

Arkansas Elite Welding Academy reserves the right to restrict school access to any student who has been diagnosed as having a contagious or communicable disease or virus. It is assumed that all students are free of any such diseases or viruses, however; if any student knows or has reason to believe he/she may be infected, they must report this information immediately to the Safety Coordinator. Any restrictions and/or exclusions deemed necessary by school officials for the welfare of all students will be determined in light of the most current medical knowledge and in accordance with state and federal laws and guidelines.

In order to be compliant with Arkansas Elite Welding Academy, state, or federal guidelines, students may be advised and/or required to leave campus and return home immediately upon notification of a communicable disease or virus. Students may also be required to obtain documentation from a Medical Doctor before they can return to campus.

### **Policy for Protecting against Copyright and Software license Infringements**

Arkansas Elite Welding Academy, LLC expects that all students of the learning community respect the rights of ownership of intellectual property by adhering to United States copyright law including the Digital Millennium Copyright Act. All Program Curriculum and Lesson Plans are the property of the Arkansas Elite Welding Academy and under its copyright.

1. It is the policy of the Arkansas Elite Welding Academy, LLC that no student or instructor may copy, reproduce, or distribute any materials within the Learning Center except as expressly permitted or with the written consent of the Arkansas Elite Welding Academy, LLC as the copyright holder or as otherwise permitted under Federal law. Willful infringement may subject a student or instructor to discipline and can impact the privilege to use information technology resources within Arkansas Elite Welding Academy, LLC.
2. Students should honor copyright laws when sharing information as part of their learning process, including articles, quotes, videos, and other materials covered under federal law. According to law, students may incorporate portions of copyrighted materials when producing a project for a specific course.
3. It is the commitment of the Arkansas Elite Welding Academy, LLC that contractually protected and/or copyrighted computer software shall not be improperly copied, distributed, or used by its students or faculty.

### **Disorderly Conduct**

Students must be aware of the school's commitment to having an environment which discourages exaggerated conduct that draws attention to oneself or to a group. Disorderly or obscene conduct, or any breach of peace on the school property, is prohibited. No student shall push, strike, or physically assault any member of the staff, administration, student body or any visitor on the campus. Horseplay or sabotage of another student's work and being out of a student's assigned work area is disruptive and will result in disciplinary action.

### **Drug Free Policy**

Arkansas Elite Welding Academy is a drug-free environment. It is unlawful to manufacture, distribute, dispense, possess, or use a controlled substance in the workplace or any area on school property, or during school sponsored activities. This also includes possession of alcohol. This applies to employees of Arkansas Elite and to students. If needed, Arkansas Elite can make referrals regarding drug counseling, rehabilitation programs, or other substance abuse assistance programs.

### **Drug and Alcohol Policy**

Arkansas Elite Welding Academy is a drug and alcohol free institution. At this time drug testing is not required to obtain admission to Arkansas Elite Welding Academy, but students may be subject to drug and alcohol testing at any time they are enrolled.

Students are prohibited from:

- Using, possessing, or being under the influence of any alcoholic beverage, illegal drug, or illegal substance, while on Arkansas Elite Welding Academy premises, regardless of age.
- Misusing over-the-counter or prescription drugs while on school premises.
- Possessing paraphernalia used in connection with any drug or controlled substance.
- Manufacturing, distributing, or dispensing illegal drugs or controlled substances.
- Buying alcohol for an underage student
- Using a fake ID to obtain alcohol

**\*\*\* Arkansas Elite Welding Academy reserves the right to search student and alumni toolboxes and vehicles while on school grounds if they are suspected of being in possession of a prohibited item.\*\*\***

The following are reasons for selection for a drug and/or alcohol test:

- Selected for a random test(s). While enrolled at Arkansas Elite Welding Academy, a student's name will always be in the random pool. Students can be chosen more than once for a random drug and/or alcohol test.
- A student is exhibiting observable behavior that leads a school official(s) to believe they are under the influence of drugs and/or alcohol.
- A student is involved in an accident or safety violation on school grounds, which could have or did result in a serious injury of themselves and/or others and/or caused property damage.
- Beginning job placement.

Upon notification that a student has been selected for a drug and/or alcohol test, he/she must report to the school's designated location for collection. Upon completion of the test, he/she will return specimen to the test administrator. If a student does not provide a valid urine and/or saliva specimen within 1 hour of a testing notification it will be considered a refusal to test resulting in immediate dismissal. A refusal to test, a tampered with, or an adulterated specimen, will result in immediate dismissal.

Students violating the drug and/or alcohol policy in any way, including having a positive drug and/or alcohol test or refusing to take a drug and/or alcohol test, is considered a major offense and may result in disciplinary action.

Drug testing is required before each student begins job placement. If the on-site test is positive, the student will be sent to Sherwood Urgent Care in Quitman for a confirmation test. If the confirmation test is also positive, the student will be dismissed from the program immediately and will receive no alumni benefits.

A student will be notified of test results only if it is positive or adulterated. Students will not be notified if results are negative. All drug and/or alcohol test results are confidential. Students have the right to request a confirmation test of positive results by the school's designated

testing facility. School officials can also request that a student be tested off-site, and if the student refuses to test, they will be immediately dismissed.

### **Harassment**

Arkansas Elite Welding Academy strives to provide a learning environment free from all types of harassment. Harassment demeans individuals and creates unacceptable stress for the entire organization. A student will be in violation of the harassment policy if they engage in any unwelcome action, whether physical, verbal, or nonverbal, towards another person. This can be a single incident or a series of incidents that occurs on or off campus.

Examples of harassment are as follows (*this is not intended to be a comprehensive list*):

- Creating an environment that is intimidating, threatening, hostile, and/or offensive
- Insulting, criticizing, taunting, or demeaning another person to the point that the action interferes with another person's academic progress or employment
- Making sexual advances, requests for sexual favors, or other verbal or physical conduct of a sexual nature, a condition of academic progress or employment
- The use of force or the threat of force to engage a person in sexual activity without that person's consent
- Hazing (visit <http://www.stophazing.org/arkansas/> for a legal definition of hazing)
- Stalking (i.e. following or contacting a person repeatedly, making that person fearful for his/her life or personal safety)
- Threatening another person's safety, privacy, property, academic progress, or employment • Displaying violence that results in physical contact
- Retaliating against a person who complains about your conduct

Harassment will not be tolerated, is considered a major offense, and may result in dismissal from the program.

### **Insubordination**

By completing an Enrollment Agreement, students acknowledge that the student catalog is accessible to them and they agree to abide by the school policies and procedures as stated. Failure to comply with the directives of a school official or other authorized guidelines is considered insubordination. Refusing to cooperate with efforts made to help the student adjust to their chosen program of study will be considered insubordination.

### **Music**

Music in your work area must be kept low and should not disturb others. Earbuds are allowed but not recommended. Hanging cords are not permitted.

### **Prohibited Materials**

Arkansas Elite strictly prohibits pornographic, lewd, vulgar, racial, or any form of provocative or demeaning material. This includes but is not limited to magazines, t-shirts, decals, stickers, electronic downloads, and material posted or shared to a student's personal social media accounts.

***\*\*Student and alumni toolboxes and/or vehicles are subject to being searched while on Arkansas Elite Welding Academy property.\*\*\****

### **Questionable Honesty**

Any form of dishonesty, including but not limited to cheating on an assignment, plagiarism (claiming the work of another person), falsification of attendance or production, forgery, and/or lying to school officials, is prohibited and may result in dismissal.

### **Sexual Misconduct**

Any individual who demonstrates obscene, lewd, or indecent behavior is in violation of the sexual misconduct policy of Arkansas Elite Welding Academy. Sexual misconduct by Arkansas Elite students is harmful to the image and reputation of Arkansas Elite and will not be tolerated.

### **Smoking and Tobacco Use**

There is absolutely no smoking or use of e-cigarettes in the shop. Students are only permitted to smoke in the designated outdoor smoking area and only during designated break times. Students should not have e-cigarettes or butane lighters on their person while in the shop. The use of smokeless tobacco is permitted. Violation of the smoking policy will result in disciplinary action.

***\*\*\*The designated smoking area is located outside the west roll up door.\*\*\****

### **Social Media**

Students are strongly encouraged to use caution when using any form of social media, video source, or any social networking website. All information posted online is public information. Pictures, vulgar language, or other documentation of students violating, or reasonably suggesting a violation of Arkansas Elite policy on or off-campus is subject to further verification by the school. All online information can be used as a personal admission of guilt. Any conduct policy violations that are documented as a result of such verification will result in disciplinary action.

### **Theft**

No student shall take, attempt to take, or keep in his possession items of school property or items belonging to others without proper authorization. Whenever theft occurs, the student shall contact a school official immediately. If deemed appropriate the school will investigate, including searches. The Sheriff's Office may be asked to assist with the investigation. Arkansas Elite Welding Academy is not responsible for personal items students choose to bring on campus. Violation of the theft policy will be treated as a third offense.

## STEPS IN DISCIPLINARY ACTION

First Offense: written document using the Student Incident Form. The Lead Instructor and Student Advisor will review the document with the student giving the student the opportunity to write a response. Both the student and the school representative will sign and date the document. A copy of the document will be given to the student and a copy will be placed in the student file.

Second Offense: written document using the Student Incident Form. The Lead Instructor and a member of the Core Management Team will review the document giving the student the opportunity to write a response. Both the student and the school representative will sign and date the document. A copy of the document will be given to the student and a copy will be placed in the student file. A suspension may occur at this time. While students are suspended, the attendance policy will apply. Hours missed because of a suspension cannot be made up. ## **APPENDIX C - PROGRAM ORIENTATION**

A day long orientation program is required on each program start date. Orientation is mandatory and must be completed in full before a student can be on the shop floor. Orientation takes place in the Arkansas Elite Welding Academy classroom.

All new students are assigned a student mentor. The student mentor will be a current student who is in good standing. The student mentor will guide the new student on their first day on the shop floor.

The following forms (pages 72 to 80) are the forms that will be mailed to each program participant approximately one month before that student's program start date. These forms must be completed and returned on orientation day. Students will not be allowed to begin on the shop floor, and will be counted absent, until all forms are complete, full payment has been made, and Arkansas Elite Welding Academy has received a copy of the student's high school diploma, high school transcript, or GED certificate. If a student will be under 18 on their program start date, a parent or guardian must also sign all forms.
